### **London International Ship Show – Bloomsbury – Saturday 21<sup>st</sup> October 2006**

It is time to write to all on the Ocean Liner Society contact lists to invite you to the London Show. It is usual hours 10.00 – 16.00 This year we are returning to the popular (and well known to postcard collectors) Galleon Suite of the Royal National Hotel, Bloomsbury. It is near all main line stations to the North and there are congestion charges on a Saturday. It is also very near Euston and Euston Square.

This show location allows considerable expansion over our time at Westminster and better display facilities. Most stands can take additional side displays or display panels can be freestanding behind. This could be our biggest Show ever so to make it a success put the word around amongst your friends and customers. This venue has level access and is air conditioned. Unfortunately the hire costs are more which we have to pass on but we still think they are very reasonable. Tables will be £93 per table for non-members of the Society, but we will do the membership amount (air mail) £25 discount scheme for Ocean Liner Society members (membership is £20 per year in UK if you are not already a member). **Thus OLS members pay £68.**

- Booking forms (ideally with cheques and credit card authorisations\*) or “No thanks” back to organiser by 1<sup>st</sup> August
- Table allocations will be done early in September – early applications will get priority allocation
- Table allocation notifications and joining instructions will be sent out end of September

Please find further down this pack a booking form, terms and show plan in two parts (half to return half to keep). Please read and retain the terms, indicate your 1<sup>st</sup> to 4<sup>th</sup> choice for positions on the plan and return the completed / amended form and plan with cheque (payable to Ocean Liner Trading Limited - with a separate membership cheque to OLS if you are joining) or one credit card authorisation. Don't forget the deadline is 1<sup>st</sup> August, please as key people will be away after that date.

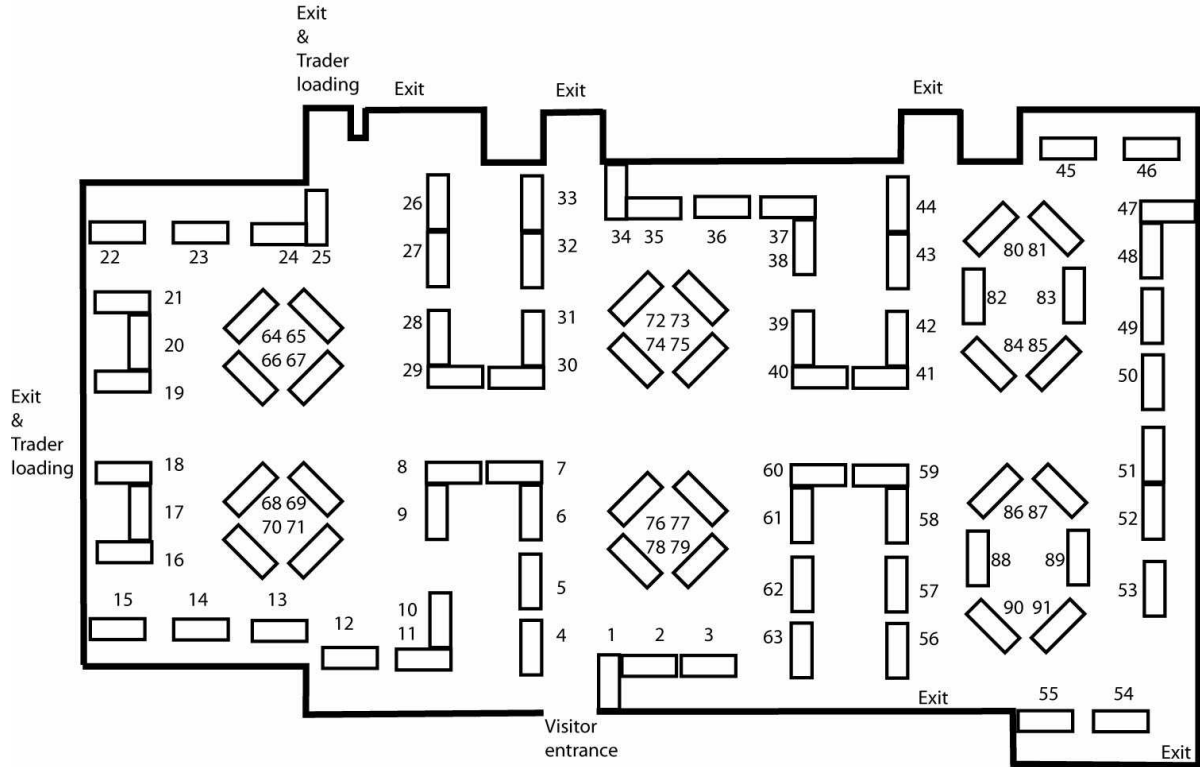

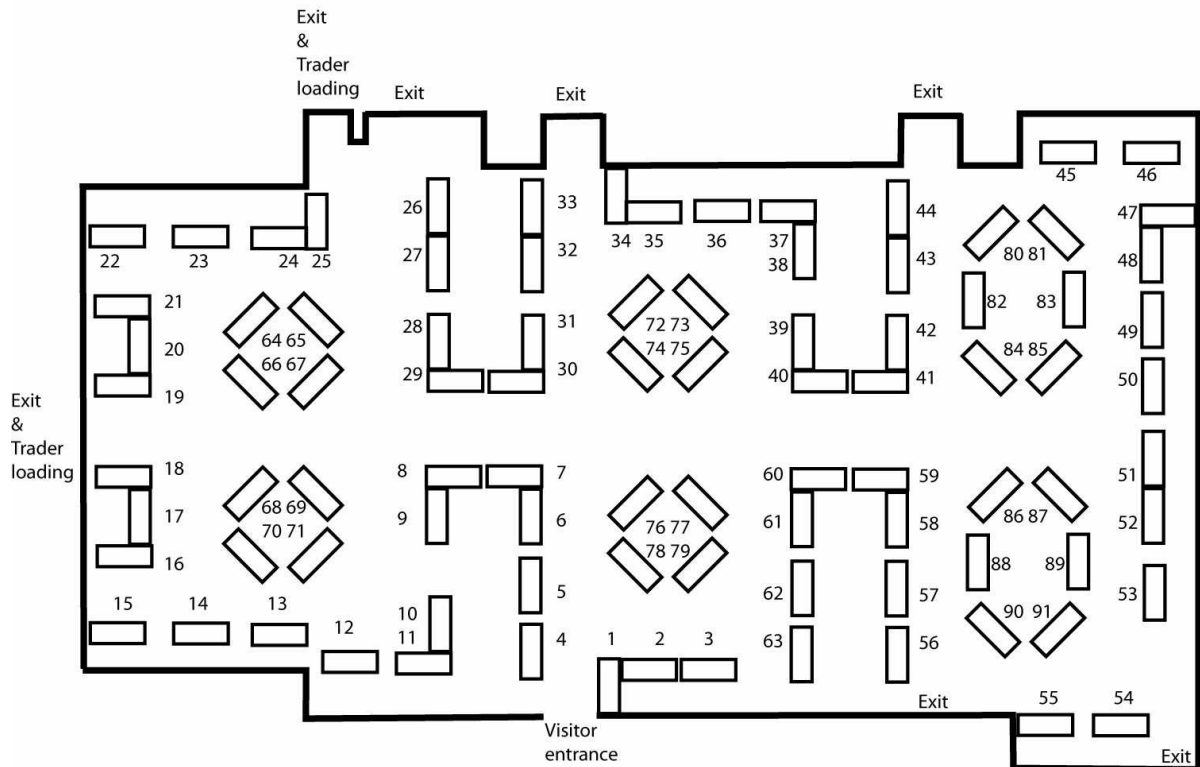

# OCEAN LINER TRADING LTD.

## Definitions:

**Exhibitor:** An individual and or an organisation that hires one or more tables and / or space at a Ship Show for display and / or trading purposes.

**OLS:** The Ocean Liner Society and / or its Officers.

**OLTL** Ocean Liner Trading Limited and / or its Directors and representatives

**Ship Show:** An event commissioned by the OLS and run by OLTL at a specified location on a specified date and time to which exhibitors are invited.

**Ship Show Organiser:** A representative of OLTL with particular responsibility for organising a Ship Show.

## Terms and Conditions

1. Undertaking by OLTL: OLTL undertakes to provide Exhibitors with tables and / or space at the Ship Show as agreed at the time of booking. When more than one table / space has been booked tables / space for such exhibitors shall be adjacent except when otherwise requested. OLTL assigns locations of exhibitors at its own discretion, but will satisfy special requests whenever possible. Other facilities may also be available (e.g. electricity) depending on the venue.
2. Payment. All payment must be in sterling. Credit card payments will be processed by the commissioning society (OLS) and will be passed on to the trading company (OLTL). Cheques must be made payable to the Ocean Liner Trading Ltd. Booking will only be guaranteed if accompanied by payment. Exhibitors booking without a payment will be invoiced, but failure to pay the invoice eight weeks before the Show may result in the booking being void.
3. Capacity: OLTL accepts bookings on a "first come, first served" basis at the address specified for the return of the booking form. If bookings exceed the capacity of the venue, then full payment will be returned to the unsuccessful applicants. (Cheque payments will be returned uncleared and credit card payments refunded to the card on which payment was made if they have been processed)
4. Cancellation by OLTL: In the event that then OLTL considers it necessary to cancel a Ship Show, then OLTL will return the fees paid for tables and/or space in full to the Exhibitors. Exhibitors will be notified in writing. If cancellation is within seven days of the Ship Show, then every reasonable effort will be made to notify the Exhibitor by telephone, fax or e-mail where this information has been provided on the booking form. In the circumstance of the venue being required for accommodation ancillary to a nearby royal or national event organised at short notice, or access to the streets around the venue being limited for a similar reason, OLTL will use its best endeavours to reschedule the event to a similar day and time in the month following the planned date.
5. Cancellation by the Exhibitor: Exhibitors may cancel bookings for the Ship Show by written notification to the Ship Show Organiser. Payment will be refunded on the following scales:
  - More than 28 days: Full payment less £5.00 service charge;
  - 7 to 28 days: Half the payment made;
  - Within 7 days: No refund.
6. Rejection of Exhibitors: OLTL reserves to right to decline an Exhibitor's application for a table / space if the Exhibitor or his / her trade or business does not conform to the objectives of the Society and/or sponsors with whom it may associate, does not conform to these terms and conditions or may bring the OLS into disrepute. Those Exhibitors whose booking is declined have the right to appeal in writing to the Committee of the commissioning Society (OLS) and a representative of any sponsor, whose decision shall be final.
7. Change of booking: Exhibitors may request additional tables up to 28 days before the Ship Show in accordance with clauses 1,2 & 3 above. Those requesting a reduction of space will be regarded as a partial cancellation and will receive refunds in accordance with Clause 5 above.
8. Safety: Exhibitors must make every reasonable effort to ensure compliance with safety conditions at the venue and for all persons during the Ship Show and the periods for setting up and clearing away before and after the Ship Show. Exhibitors bringing their own stands, shelves and display systems must confine them to the table top or area behind their table, unless they have been allocated to spaces where tables may be safely extended.
9. Liability of OLTL: The liability of OLTL shall not exceed the fee paid for tables and or space. OLTL will under no circumstances be liable for any loss of or damage to exhibitors' property.
